



## Equal Employment Opportunity and Affirmative Action Policy Statement

It is the policy of Crane Aerospace & Electronics that we will recruit, hire, train, and promote persons in all job titles, and ensure that all other personnel actions are administered, without regard to race, color, religion, national origin, sex, sexual orientation, gender identity, military or protected veteran status, the presence of any sensory, mental or physical disability, creed, age, marital status, or other legally protected status, and we will ensure that all employment decisions are based only on valid job requirements.

Crane Aerospace & Electronics is a federal contractor subject to Executive Order 11246, Section 4212 of the Vietnam Era Veterans' Readjustment Assistance Act of 1974, as amended (VEVRAA) and Section 503 of the Rehabilitation Act of 1973, as amended (Section 503). Crane Aerospace & Electronics is committed to equal employment opportunity, and it is Crane Aerospace & Electronics' policy to take affirmative action to employ and advance in employment minorities, females, protected veterans and individuals with disabilities. Crane Aerospace & Electronics will also provide reasonable accommodation to known physical or mental limitations of an otherwise qualified employee or applicant for employment, unless the accommodation would impose undue hardship on the operation of our business.
